

- 3. The school must submit it's information through Online Affiliated School Information System (OASIS) as per the Board's Circular No:CBSE/Aff./4/Circular/2016, dated 10.11.2016, within 30 days from the receipt of this grant letter. Link for OASIS is available on Board's website: www.cbse.nic.in.
- 4. The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Middle/Secondary/Sr. Secondary School Examination and changes made therein from time to time.
- 5. The school shall appoint only qualified and eligible staff.
- 6. The school will help the Board in the smooth conduct of the examination by providing the necessary accommodations i.e. Rooms, Halls, etc. available in the school premises and furniture at its disposal for holding its examinations free of charges if required.
- 7. The school will spare sufficient teachers, for invigilation purpose at the examinations of the Board, as may be required.
- 8. The school will spare its teachers for evaluation of answer-books for the Board's examinations, if required.
- The school will provide Laboratories, Library and other facilities as per norms of the Board.

14. The rate of tuition fee and other fees charged should be commensurate with the facilities provided.

15. The admission to the school shall be opened to all without any discrimination on the ground of religion, cast or race, place of birth or any of them.

16. No unrecognized classes shall run within the premises of the school or outside in the same name of school.

17. The School will not sponsor candidates for Board's examination of any other School/Branch,

18. The school will create Reserve Fund as per the requirement of the Affiliation Bye Laws/Rules of the Directorate of Education, Delhi in the joint names.

19. It will continue to pay Annual Fee of Rs.5000/- per annum. The schools run by Govt./Govt. Aided are granted regular affiliation and these schools have been advised to remit prescribed annual fee through link provided on Board website www.cbseaff.nic.in.

20. Annual fee has been received upto 31/03/2021.

21. The school is required to contact the concerned Regional Office of CBSE for allotment of school number and password for online Registration of candidates.

22. Special Conditions to be completed by the School within three month.
